#### 9. Legal declaration of Indemnity

9.1 Neither ETI nor any official employee or representative of ETI acting in his/her capacity as such shall be liable for any damage arising out of:

- a) the death, bodily harm, loss of health or illness of any student howsoever caused; and
- b) the destruction of or damage to any property owned by or in the custody of any student, howsoever caused.

9.2 The applicant hereby indemnifies ETI against any claim made against ETI in respect of any damage arising out of the fault of the applicant.

#### 10. Conditions of Registration

All details regarding registration and termination of registration are contained in the ETI Programme outline, the Fee Schedule, Procedures and Rules and other relevant ETI documentation, the contents of which are deemed to have been read and understood by the signatories hereto. Furthermore, the following terms and conditions are agreed to:

10.1 The student's failure to attend lectures/workshops or complete Distance Learning modules for whatever reason shall in no way entitle him/her to a reduction in fees, nor will it absolve him/her or the other signatories to this document from full liability for the payment of fees and other charges;

10.2 No cancellation of this contract shall be of force or effect without written consent thereto by an authorized officer of ETI.

10.3 The right to attend lectures/workshops and write examinations is not transferable;

10.4 The signatories hereto accept that ETI shall have the right to vary the course syllabus at any time, without prior notification and without furnishing reasons there for. ETI shall further have the right to alter timetables and course commencement dates where necessary;

10.5 ETI shall have the right at its sole discretion, to cancel tuition in any course or subject initially advertised and offered, on the basis of insufficient demand. ETI further reserves the right to combine classes of a similar academic level and content:

10.6 ETI reserves the right to create and apply rules (including due performance requirements), and the student hereby agrees to be bound by such rules. ETI reserves the right to exclude the student from lectures and examinations (without in any way detracting from the right of ETI to recover fees payable), and to withhold a student's examination results or to dismiss him/her for failing to pay tuition fees or failing to comply with any rules, or the terms of this contract. The student and other signatories hereby agree to pay any and all tuition fees as and when they fall due at ETI. When failure to do so results in legal or other action being taken by ETI, the liability for all costs relating to such action will fall on any signatories to this contract other than ETI jointly and severally. Such costs will include attorney/client costs and any other costs incurred by ETI, including but not limited to, attorney and client fees, collection charges, tracing charges and the maximum interest permitted by prevailing legislation (calculated from date of non-payment); 10.7 Where tuition fees are payable to ETI in instalments, the failure to pay any single instalment timeously will result in the full balance becoming immediately due and payable without further notice;

10.8 Fees payable to ETI comprise tuition and registration fees (for Distance Learning all course materials and workbooks) and do not include

- external institute membership fees, external examination fees, stationery or other items.
- it shall be the student's responsibility to bear the cost of transport and specialized consumables used during the course including but not restricted to specialized stationery, stock or any other materials and overnight accommodation if necessary
